## **TERMS & CONDITIONS FOR MOËT & CHANDON LUCKY DRAW**

These terms and conditions ("T&Cs") govern the Moët & Chandon lucky draw ("Contest") organised by Moët Hennessy Diageo Singapore Pte Ltd. ("MHDS"). All persons registering or taking part in this Contest (the "Participants") agree to be bound by these T&Cs.

- 1. This Contest is open to all residents of Singapore **aged 18 years and above** at the time of entry who have fulfilled the eligibility requirements as set out in these T&Cs ("Qualifying participants").
- 2. Employees of MHDS, its affiliated companies, agencies, participating outlets and promoters engaged by MHDS in connection with this Contest (collectively, "contest service providers") and their immediate family members are not eligible to participate.
- 3. The Contest will run from 09:00 on 10 August 2025 to 23.59 on 23 September 2025 (SGT), both dates inclusive (the "Contest Period").
- 4. To enter:
  - a. Participants must make purchase any **Moët & Chandon** product from the participating outlet(s) ("Qualifying Purchase").
  - b. Participants must scan the QR code displayed at the participating outlet(s) and submit their entry via the official microsite, including a valid receipt.
  - c. There is no limit to the number of entries per person, but each Qualifying Purchase must be submitted separately, and each Participant is only entitled to win one prize if successfully drawn.
  - d. Only valid receipts dated within the Contest period and clearly showing the purchase of Moët & Chandon products will be accepted.
- 5. Only entries that are considered as complete and correct by MHDs will be eligible. Incomplete, illegible, or duplicate entries will be disqualified.
- 6. A total of 20 winners will be selected from the pool of Qualifying Entries to receive one of the following prizes:

- 9. Winners will be notified via the email address or phone number provided at entry.
- 10. If a winner does not respond within 5 working days, the prize will be forfeited and a new winner will be selected.
- 11. Winners will be notified with information on how to claim the prize(s).
- 12. Prizes won are given out on an "as it is" basis, and are non-transferable, non-exchangeable, and not redeemable for cash. To the extent not prohibited by law, all warranties and representations in connection with the prizes are expressly excluded.
- 13. Winners shall collect their prizes on his/her own account, and shall comply with and be bound by all terms which the prizes may be subject to.

- 14. Certain prize redemptions are subject to additional terms and conditions imposed by MHDS, the participating outlets, venues or establishments as the case may be.
  - To receive their prizes, winners may be asked to present their NRIC or proof of identity as verification documents and/or asked to return a signed letter of acceptance in accordance with the instruction provided by MHDS or its managing agency, together with all details that may reasonably be required by MHDS for the issuance of the prize to the winner.
  - For activity-based prize(s) such as but not limited to, hot air ballon rides or similar adventure activities, winners explicitly acknowledge that such activities involve inherent risk that may result in personal injury, property damage, or in rare cases, death. If a winner declines to sign the required liability documentation or is determined to be medically unfit for participation, the prize will be forfeited, and MHDS may, at its sole discretion, select an alternative winner. Winners must agree to follow all safety instructions provided by the activity operators and acknowledge that failure to comply may result in immediate termination of participation without compensation.
  - For prize(s) involving participating on-trade outlets or restaurants such as Moët Grand Vintage Glass with Tempura Pairing Experience at the Spirit of 1743 Pop-up with Mini Moët takeaway, and Moët Grand Vintage Bottle with purchase of food at participating on-trade outlets, prize redemption may subject to additional terms and conditions ("Merchants-specific terms"). Winners must comply with all Merchant-specific terms, which may include reservation policies, availability constrains, age restrictions, minimum purchase requirements, consumption guidelines or the like. These Merchant-specific terms are determined by the participating merchants and will be provided to winners upon prize confirmation.
- 15. Any portion and/or condition for redemption of a prize not accepted by a winner will be forfeited. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility.
- 16. MHDS may, without notice and at any time, substitute any prize with a prize of similar or greater value, as determined by MHDS.
- 17. By entering, participants expressly consent to the collection, use and processing of their personal data by MHDS for the purposes of administering this Contest. MHDS may, for this purpose, disclose your personal data to its managing agents, contractors and/or service providers, including but not limited to contacting winners, awarding prizes, and publicizing the results of the Contest. The collected personal data may include full name, date of birth, and contact details such as email address and phone number. MHDS will collect, use, process and protect participants' personal data in accordance with MHDS's Privacy Policy.
- 18. By entering, each participant agree to
  - comply with and be bound by these T&Cs. Non-compliance with or breach of any of these T&Cs may result in the participant being disqualified at any stage of the Contest, and any prizes won may be forfeited, withheld, withdrawn or reclaimed.
  - releases MHDS and/or its contest service providers from and agrees to indemnify MHDS and/or its contest service providers and any of MHDS's officers/ employees/ directors/ representatives/

- agents from and against all liability, cost, loss or expense arising out of acceptance of the prize or participation in the Contest including (but not limited to) personal injury and damage to property or any violation of any law and whether direct, indirect, consequential, foreseeable, due to some negligent act or omission, or otherwise.
- release MHDS, its affiliated companies, contest service providers, and their respective officers, directors, employees and agents from any liability whatsoever for any claims, costs, injuries, losses or damages of any kind arising out of or in connection with participation in the prize activity.
- In no event shall MHDS, its affiliated companies and contest service provider, including the employees of all of the foregoing, be liable to any participant and/or to any party for any damages, expenses, claims, costs or losses of any kind, including without limitation, incidental, indirect, consequential, special, punitive or exemplary damages of any kind, including lost revenues or profits, loss of business or loss of data.

To the fullest extent permitted by law, MHDs shall not be liable for any damage, injury death, claim or loss (including loss of profits or indirect, consequential, incidental, special, exemplary or punitive loss or damage), howsoever caused (including through the negligence), suffered or incurred by the participants or any person arising from or in connection with the participants' participation to/in the Contest, including but not limited to participants' access to, or use of, the microsite, the participation in the Contest, acceptance of the prize, use/misuse/redemption of the prize and any decision or action taken by the participant.
- 20. MHDS reserves the right to amend these T&Cs or cancel the Contest at any time without prior notice. MHDS's decisions with respect to all aspects of the Contest are final and no correspondence will be entertained.
